We can place a puppy on hold for 72 hours. The Buyer must return the signed contract and requisite non-refundable deposit within 72 hours. Otherwise, Poos4U cannot guarantee the availability of the contracted puppy.

A non-refundable deposit of \$300.00 for any puppy up to \$1,000.00 sale price and a \$500.00 non-refundable deposit for any puppy over \$1,000.00 sale price will hold any available puppy until the date of pickup or shipping. Puppies must be paid in full before shipping.

ALL POOS4U PUPPIES COME WITH:

- A.K.C. or C.K.C. registration papers (if applicable) and an internationally registered microchip.
- One-year health guarantee
- Puppy carrier (if puppy is shipped) and/or a Puppy Welcome Home Bag
- Complete physical exam, including fecal exam and a health certificate from a licensed veterinarian.

TERMS AND CONDITIONS

1. Tami Foster (Poos4U, LLC.) reserves the right to refuse service to anyone.
2. Deposits/payments: Contract deposits are considered a commitment of purchase from Poos4U. Once the contract is signed, the buyer forfeits the full amount of the contract deposit to Poos4U. If the buyer forfeits the final purchase of the puppy *for any reason*, monies paid toward the final purchase price, less the listed contract deposit, will be refunded to the buyer within 30 days.
3. If, for some untreatable health reason, death or other unforeseen factor occurs to the puppy while still with the breeder after the initiation of this contract, the breeder will apply the deposit toward the purchase of another puppy of comparable value or a difference paid by the buyer for a puppy of greater value. Replacing a puppy can take up to a year, but a replacement puppy or dog is guaranteed by the breeder.
4. The breeder guarantees a healthy companion pet, but does not guarantee adult size, color, and temperament. Nor does Poos4U guarantee fitness for breeding. All hernias (inguinal) will be repaired before leaving if found by my veterinarian to be necessary to repair (in the Shih Tzu, umbilical hernias are common, generally reduce with age, and are not usually worthy or necessary of surgery, nor do they make your dog exempt from showing) Hernia repairs do not warrant a return of money, as it is not life-threatening and in no way interferes with the quality of life of the puppy.
5. A.K.C. or C.K.C. registration papers for any puppy sold with such will be supplied or mailed as soon as the breeder receives them.
6. This contract supersedes all previous agreements.
7. Puppies sold must remain on 4Health dry & canned food or same quality (i.e. Pure Balance, Blue Buffalo, Dish, Blue, Solid Gold, OMH Wellness, Wag, or Nutro) for 1 year; if not, guarantee is null and void.
8. This contract is null and Void if the terms and conditions are not fulfilled.

1 YEAR HEALTH GUARANTEE

All puppies sold by Poos4U will have current shots and deworming (according to age and size of puppy) and a physical exam. Poos4U will provide the buyer with a copy of the puppy's shot records and a health certificate from a licensed veterinarian. Poos4U provides a 12-month health guarantee against congenital defects and illness originating prior to the buyer taking possession of the puppy. The health guarantee begins on the date that Poos4U releases the puppy to the buyer. Certain disorders may be caused by environmental factors (i.e., allergies, thyroid dysfunction, demodectic mange, and other autoimmune disorders) that are not covered by this guarantee.

Congenital Defects: If your puppy develops a condition that dates back to the fetal stage and this condition would severely impact the quality of the puppy's life, short of euthanasia, then you will receive a replacement puppy. This must be documented by a licensed veterinarian.

Death: In case of a death, an autopsy stating the cause of death is required to verify no fault on the owner's behalf before allotting for a replacement puppy. No money is ever refunded. No replacement can be made until signed and returned registration papers are sent to the seller along with signed autopsy findings.

Poos4U Health Guarantee is void if:

The puppy fails to receive appropriate and documented veterinarian care.

The health guarantee is Void if the puppy is bred before it reaches 12 months of age.

The health guarantee only applies to the contracted buyer; it will be considered forfeit if the buyer transfers ownership of the contracted puppy to another person. If the health guarantee is exercised, it is subject to the availability of another litter, which could take up to one full year.

Buyer's acceptance of this contract constitutes that an agreement has been met and this sale has been consummated within the state of Florida, and consents to the application of all Florida laws and to the jurisdiction of Florida courts. Should the buyer default on this contract, then he or she shall be responsible for all attorney fees and court costs involved in the event of arbitration or litigation.
